Chair's Report:

2014-2015 was a challenging year for PAC. Due to the continuation of the previous year's school strike we started the 2014-2015 school year almost three weeks late. This of course had an immediate impact on one of PAC's 2 most important fundraisers: Fun Lunch. Fortunately, through her commitment to making this program succeed Hoda Seraji managed to get this critical fundraiser back on track last

year, and off to a very quick start this year.

In November, PAC transitioned from an Executive Chaired by the experienced and capable Nicole Brown to me. Fortunately for me, I received enough support and guidance from Nicole, Eileen Huster and Monika Wilson to be able to at least function in the role. And then Mark Roozbahani stepped down from his role as Treasurer due to increased responsibility and demands at work. Fortunately Assistant Treasurer Lynn Mooney continued paying the bills and then former Treasurer Connie Hart stepped in to save the day by taking on the role once again.

And that leads us to PAC's other critical fundraiser, Gala, which owing to a slump in advance ticket sales was in danger of being canceled in the final weeks leading up to the event. Fortunately, through a lot of effort Co-Chairs Jenn Rainnie, Lisa Wilkinson and their team of volunteers managed to sell enough tickets to not only stage the event, but make it a successful one.

Given the challenging start to the 2014-2015 school year, given an increasing difficulty communicating with and engaging parents and attracting volunteers, last year's PAC Executive took on the view that going forward we have to look at ways to reduce spending where it makes sense, to try to make spending more predictable, and make an even greater effort to be

accountable to our parents, whose fundraised dollars are what makes it possible to support and run programs to benefit the students in the first place. A number of measures were taken, including, as voted on in PAC General Meeting, PAC taking control of the parent-funded Principal's Discretionary fund, which is now the smaller PAC Financial Assistance Fund. Additionally, as voted on the Quebec Trip rebate was changed from 30% of all fundraised dollars to a capped amount of \$12,000, with PAC encouraging Grade 7 students (with the help of their parents) to make an effort to raise additional money through complementary fundraisers. These changes, though not without controversy, are aimed at freeing up money that can be used this year and in the future to benefit the entire school population.

2014-2015 was indeed a challenging year for PAC, but we came through alright, and it's my belief that this year we will have a PAC Executive and Committees that are up for whatever challenges this year presents.
